#### Qualitative analysis of Criterion 1

Patrasayer Mahavidyalaya college is situated in the rural area and was founded in 2005. It is Grant- in -Aid, co-educational institution. The college is affiliated to Bankura University since 2017. The college is run by Governing Body whose President is selected by Higher Education Department, Govt. of West Bengal and the Principal functions as secretary of the governing body. The college is offering 10 Under Graduate courses including Honours and General. The college follows the syllabus of the affiliating Bankura University in which few teachers of the college are members of Board of studies. The college successfully implements the curriculum through its academic calendar and designed timetable. The Academic calendar of the college is provided to students and is displayed on College Website. Provision for online and offline teaching is very much in order. Issues like, human values, environmental and sustainable development, waste management, renewable energy, conservation, gender equality, women empowerment are kept in focus in the college. Feedback system is in place but analysis still to be taken into action and Mentor-Mentee system is followed. More Add on and skill courses are yet to be introduced. For enrichment of curriculum, Environment, has been created and are discussed with student.

# Qualitative analysis of Criterion 2

Campus offers graduation programms in two languages that is English and Bengali medium. Admission to these courses is done on merit basis and reservation policy is followed as per State Govt. rules. Induction programme is organized to make Students aware of college activities at the start of the every academic session. Remedial classes are also held for needy students. Lecture methods, experimental learning, project method, participative learning, problem solving etc. have been used to impart learning experiences to the students. Faculty prepare lecture plans and also maintain a weekly record of what has been done in classrooms. Feedback from students is also taken to know about their understanding about the classes attended by them. Evaluation is done internally and externally as per University rules. Efficient mechanism is adopted by the institution to deal with grievances related to internal assessment. Nine teachers appointed by the Govt. work on permanent basic against the thirteen sanctioned posts. Twenty teachers work on management quota sanctioned by the Governing Body under management basis and six teachers work as Guest faculty. Out of thirty six teachers seven are Ph.D. and four are pursuing their research. Six teachers are NET/SET, and rest are Post Graduates. Programme out comes and course outcome are monitored from time to time and Pass percentage of students is above the mark.

Qualitative analysis of Criterion 3

The institute has created a research cell and encourages faculty to undertake research projects. One of the teachers got Full Bright Scholarship in USA. Presently no grants from Govt. or non -govt agencies have been received by the college for the purpose. A few teachers have published papers in peer reviewed journals. The college encourages faculty members to participate in seminars and conferences organized both at State and National level. In the assessment years College has organized seminars on issues such as Intellectual Property Rights, Gender Sensitization, role of women in NSS, student credit cards etc. Career counselling is also provided to students. Certain extension activities by NSS unit have been carried out, such as campus cleaning and distribution of food packets to the hospitals. The college celebrates all National days/festivals as per the schedule.

## Qualitative analysis of Criterion 4

The covered area of the Campus is 1579.35 sqm. The college is having 15 classrooms, 01 Geography laboratory, 02 smart classrooms, 01 seminar room, 01 cycle stand and Indoor and outdoor sports facilities are available. Toilets for both boys and girls are available and ramps for differently-abled student are in place. The college is having a big play ground where the provisions for games such as volleyball, football, cricket have been made. Seminar Hall, common room, washrooms separate for boys and girls. The campus is covered under CCTV surveillance. Solar panels for electric energy are being used. College has library in which about 9000 number of books, journals and Newspapers are available. Library is partially automated. The college is having Seventeen numbers of Computers for use of students and staff. The Accesses to a few e-recourses are also available for students and staff. Adequate facilities for activities such as yoga, cultural and other co-curricular and extracurricular are available. The Internet connectivity of 60 mbps has been provided and the whole campus is Wi-fi enabled. Maintenance of infrastructure is as per requirements.

Student centric approach is followed by the college to benefit the students enrolled in the college. Student mentoring is done, right from the start of every academic sessions and till they pass out from the college. The students are provided services like academic and career counseling / guidance. The financial support is provided to needy students both by the staff and the government especially to reserved categories. The students are involved in both co-curricular and extra -curricular activities. Academic calendar and E-prospective of information is provided to them at the start of the session and the website is regularly updated. Being a public institution of Higher Education, students are provided half tuition fee facility and scholarship is also provided to needy and deserving students. The NSS unit organizes Annual camps to develop interpersonal skills, communication skills and social skills. Grievances Redressal cell and Anti-Ragging cell also looking after needs / grievances of students. Cultural and sports activities are carried out regularly. However in sports and cultural activities no remarkable award have been achieved by students at National level. Alumni

Qualitative analysis of Criterion 6

The Management of the college has clear vision and well-defined goals and future plans. The decentralized and participative management runs with top to bottom and the Suggestions made by faculty regarding academic, administration and infrastructural development through constitution of various committees are taken into account and implemented on priority basis. IQAC has been constituted and is working as per NAAC guidelines. A few trainings and workshops of short and long duration for teachers, and students have been conducted from time to time. Motivation of students, to enhance their practical knowledge, ICT based teaching, organization of study tours, are the initiatives taken by management .Certain welfare schemes such as GPF scheme, medical and casual leaves, free wi-fi facility, timely salary disbursement through DBT mode, easy access to with drawl of provident fund as per rules provided to non-teaching and teaching staff. A few teachers have attended Faculty Development programmes during the last three years but no such programme has been attended by non-teaching staff. Internal and external Audit is done as per rules. Management and IQAC committee meets and major policy decisions are taken by them. However no grants from government or private agencies have been received by college for research. In order to ensure punctuality of staff, Bio-metric attendance system is in place and is being maintained with transparency.

Creation of You-Tube channel, Mentor-Mentee relationship, on-line e-magazine and learner- centered way to empower students is taken as the best practice by the college. Monthly Teacher council fund is raised to finance the deserving and needy students.
